

PRIVACY POLICY

Reiki Federation Ireland

1. RFI trading as Reiki Federation Ireland (“RFI”, “Reiki Federation Ireland”, “we”, “us”, “our”) is committed to protecting the privacy of users of this website. We are aware that as a user of this website you care about the security and privacy of your information.
2. As you use this website information is received and stored by us. This information is used to enable us to improve the website and to enable us to respond to your requests.

Technical details in connection with visits to this website are logged by our internet service provider for statistical purposes. No information is collected that could be used by us to identify website visitors without their consent. The technical details logged are confined to the following items:

- The IP address of the users webserver
 - The top level domain name used (for example .ie, .com, .net, .biz)
 - The previous website address from which the user reached us, including any search criteria used
 - Click screen data which shows the traffic of users around this website (for example pages accessed and documents downloaded)
 - The type of web browser used by the website user
3. RFI will make no attempt to identify individual visitors, or to associate any technical details listed above with any individual. It is the policy of RFI never to disclose such technical information in respect of individual website visitors or any third party apart from our internet service provider who are bound by confidentiality provisions in this regard (unless obliged to disclose such information by a rule of law). This technical information will only be used by RFI for statistical and other administrative purposes.
 4. In order to use this site effectively or to receive services supplied, you will be asked for information when you register with us. We will require, amongst other things your name, email address and mailing address to register you on the website. In addition, when you purchase an item on the website, we will also require your credit card number.
 5. The information received from you will only be disclosed to such third parties as may be necessary, in order to process any orders for merchandise as you make through this site and in order to arrange delivery of same. The information received from you may also be disclosed to carefully chosen business partners who will only use such information for the purposes of marketing their products and services to you.
